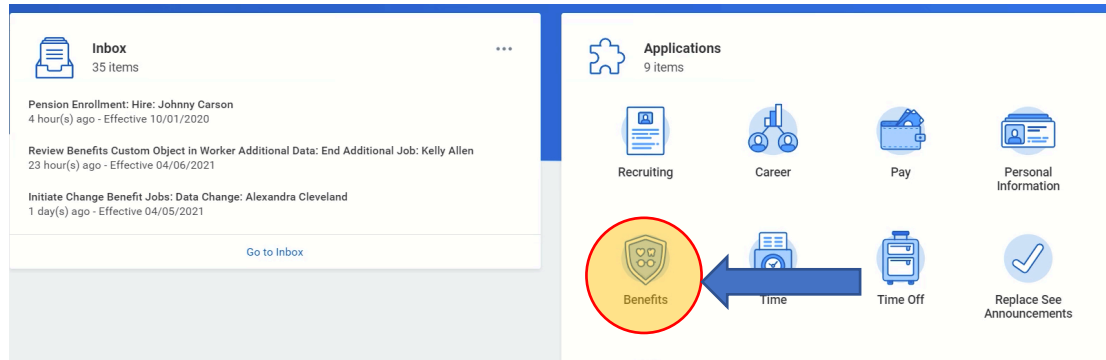


Adding Retirement Elections (403b, 457, Roth)

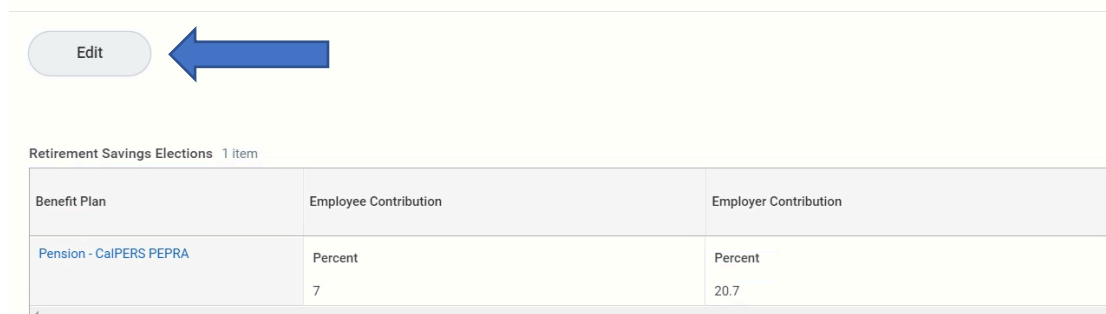
Login to Workday and Select the Benefits Application on the home page.
