Report From Grossmont Council

In the absence of Grossmont Vice President Pat Murray, Rocky reported that Pat has been working on Classified Staff Appreciation Day and that registration materials would be sent out via e-mail in the next few days. Pat has developed an on-line registration process.

Report From Cuyamaca Council

- Alan Ridley reported for Maggie Gonzales. He explained that Maggie had suggested that a
 Past President position be added to the Constitution and Bylaws. The Past President would
 serve in an advisory capacity to his/her successor, and be non-voting.
- Alan also reported on the Innovation and Planning Council (IPC) meeting. He explained that an academic review panel will be looking at Operating Procedure ST4, Student Fees Deferral Procedure.

Report From Executive Chair/District Budget

- Rocky reported that plans are moving along on schedule for the upcoming Classified Staff Appreciation Day. He said that the goal is to have a type of food court for the luncheon. If the food court does not work out, there is the option of using a caterer.
- Rocky said that he has sent a budget to Dr. Suarez regarding representative for 4CS. He will also discuss issue at Classified Leaders meeting with Dr. Suarez on March 2. Rocky also reported that Ben Lastimado suggested that cost of representative be shared by each college, the District, and Classified Senate. There could also be funds available from the State 4CS.
- Rocky discussed proposed changes to the Constitution & Bylaws: addition of Past President, election of senators, number of days notice for making changes to Bylaws. He said that he would send a summary of the proposed changes to the E-Board members for their review/approval.

Following review by the E-Board, the Constitution & Bylaws will then be sent to all Classified staff via e-mail for review/approval. A ballot will accompany the Constitution & Bylaws. A ballot box will be available at Classified Staff Appreciation Day for casting the ballot, or it can be sent to Rocky via interoffice mail.
