<u>District Strategic Planning & Budget:</u> 10/13/2014 – Next Meeting is 11/10/2014

- All site Councils will be working with consultants on Phase II of Staffing Plans 10/23 and 10/24.
- The schedule of the FTES Taskforce was discussed on whether to have a meeting sooner to plan accordingly. A strategic enrollment meeting will happen in December, and then the FTES taskforce will meet in January 2015.
- Communication needs to go out regarding the fifty percent law calculation. Education Code¹ Section 84362 requires community college districts to expend during each fiscal year for the payment of the salaries of classroom instructors fifty percent of the districts' current expense of education. Classified Leaders Meeting: 10/09/2014 – Next Meeting is 01/08/2015

- Discussed shared governance classified participation and professional development participation. It was noted a workshop for all groups will be helpful to inform all parties about what shared governance is.
- Discussed the signing of AB 2558, community colleges faculty and staff development. Reps from each site will be attending the CCC Professional Development Clearinghouse Summit 11/5 along with other reps from multiple colleges to discuss the next steps. What's next? According to 4CS President Maureen Chenoweth, "keep an eye on the budget. 25 million has been requested this year for Professional Development. This bill will make sure that classified are a part of that, so:
 - 1. Keep an eye on the state budget that will be released in January with the May revise to follow as that amount is subject to change.
 - 2. Make sure that you have classified representation on your Professional Development committee on your campus. To receive funding, your college will need a plan to include ALL employees. The college must demonstrate that the plan has developed through the governance process.
 - 3. Make a plan to monitor participation. To receive this funding, the college must also demonstrate that ALL employees are included!
 - 4. Make sure that your college is represented in the PD summit meetings this fall. I still only have about 15 colleges participating.
 - 5. We will also keep you informed of the Professional Development state governance committee that will finalize the Title 5 language and represent staff needs to the Chancellor's Office.
- Classified Staff Appreciation Day was discussed and Chancellor's Cabinet was invited to participate in the Morning Welcome. Plans for CSAD are underway and begin 10/23.
