### College Course Description

This course provides an introduction to the theory, terminology, and operation of single camera video production, including composition and editing techniques, camera operation, portable lighting, video recorder operation, audio control and basic editing. This course focuses on the aesthetics and fundamentals of scripting, producing and directing on location, post production, and exhibition/distribution.

### Required Content for Articulation

1. An overview of the process of pre-production, production and post-production camera operation including recording formats, lens operation, basic filters and tripod use.
2. Picture composition.
3. Basic lighting techniques and equipment.
4. Basic audio including different microphones and mounting techniques and appropriate sound theory (i.e. balance, presence and perspective).
5. General concepts of acting and directing.
6. Post-production theory (i.e. continuity and dynamic editing) plus basic operation for nonlinear editing including ingest, editing operation and distribution.

### Required Competencies (SLOs) for Articulation

Upon completion of this course, students will be able to do the following:

1. Recognize, recall and apply principles and processes of professional video production;
2. Operate digital video production equipment to capture original images and sounds to professional standards;
3. Create video assignments using digital recording equipment and computer based editing stations;
4. Analyze, compare and discuss technical and creative elements in video programs.

**Assessment Methods**

A grading system will be established by the instructor and implemented uniformly. Grades will be based on demonstrated proficiency in subject matter determined by multiple measurements for evaluation, one of which must be essay exams, skills demonstration or, where appropriate, the symbol system. Assessments may include the following:

1. Instructor evaluation of individual and/or group video projects assigned for the semester.
2. Classroom review and critique of programs by the instructor and enrolled students.
3. Final capstone project (i.e. music video, short drama, one act play).
4. A written midterm and a written final examination.
