BOARD TAKES CUYAMACA COLLEGE CTE TOUR

Water and Wastewater Technology; Additive Manufacturing (CADD); and Environmental Health and Safety



Management (EHSM) were three programs Governing Board members learned about in a Cuyamaca College Career and Technical Education (CTE) tour led by Vice President of



Instruction **Wei Zhou** and Dean of CTE **Kate Alder**. Providing overviews of the programs were coordinators **Joe Young** (Water and Wastewater Technology); **Cyrus Saghafi** (CADD) and **David Ivester** (Environmental Health and Safety Management.)

Tour highlights:

- There are 14 programs that make up the CTE department at Cuyamaca College.
- Conversion of the "L" Building into the Center for Water Studies will mean the addition of an Outdoor Above-ground Demonstration Water System and Lab.
- CADD student Jack Bauman demonstrated the 10 3-D printers the CADD program acquired last August. Students in an additive manufacturing course learn how to design parts used in manufacturing and "print" them as 3-D objects.
- Cuyamaca's EHSM program addresses a vital need for industry professionals to stay up to date on safety regulations and the latest in EHSM technologies.

CITIZENS BOND OVERSIGHT COMMITTEE VACANCIES FILLED

The Governing Board appointed **Pei-Hua Chou** and **Evan Esparza** to fill vacancies on the Citizens Bond Oversight Committee (CBOC). **Chou** fulfills the requirement for a representative who is an active member of a senior citizens' organization. **Esparza** fills the Cuyamaca College student position, vacant due to the resignation of **Nathan O'Hare**.

Speaker **Nick Marinovich** told the board he applied for the senior organization position. He praised the CBOC website, its annual report, and professionally conducted meetings, but recommended training for CBOC members on their role and revising the selection process. Governing Board President **Bill Garrett** said the comments would be taken under advisement

FROM CLOSED SESSION

The Governing Board, by a vote of 4-0 (Trustee Greg Barr absent), to accept the recommendation for permanent expulsion from both Grossmont and Cuyamaca Colleges of a student identified as number 5193.

BOARD REPORTS

Board members reported the first AlumniFest for community colleges at the March 11 San Diego Gulls hockey game was a tremendous success. Cuyamaca College student trustee **Evan Esparza** and Grossmont College Student Trustee **Rafael Navarrete** dropped the ceremonial "first puck." More than 2,300 tickets were sold, exceeding the goal of 2,000. They commended Associate Vice Chancellor of Advancement and Communications **John Valencia** his team and others for making the event so successful.

Esparza and **Navarrete** said student elections would take place on both campuses in April and May. **Navarrete** attended the recent active shooter training held at Grossmont College by the San Diego Sheriff's Department.

Board member **Debbie Justeson** thanked the Cuyamaca College Career and Technical Education program for the preboard meeting tour and demonstrations. Justeson said program tours enable board members to talk to the community about district programs. Trustee **Edwin Hiel** said there are great plans for growing these programs, which demonstrate a lot of personal effort and dedication on the part of faculty.

President **Bill Garrett** reported he is running unopposed for re-election. He will be deemed automatically elected and seated on the Governing Board for a new four-year term. Vice President **Mary Kay Rosinski** filed for re-election, but did not file a candidate statement because of plans to retire and move out of state in 2017. There are two challengers for her seat.



BOARD ACTIONS

With the exception of items 201, 202, and 203, all other items on the docket were approved by consent.

The Governing

Board approved Cuyamaca College credit course, certificate, and degree changes, which will be published in the 2016-2017 Cuyamaca College catalog. Curriculum co-chairperson **Chuck Charter** informed the Governing Board several courses needed State approval on an early timeline in order for them to be offered in fall 2016. Chancellor **Miles** said there has been a great deal of interest in viniculture, one of the offerings geared toward helping fill industry needs for trained employees.

The Governing Board voted 4-0 (Barr absent) in favor of sending a letter expressing support of AB 1690 (Medina), Community Colleges: Part-Time, Temporary Employees. AFT representative **Seth Slater** said the legislation would require all California community college districts to engage in collective bargaining with part-time faculty regarding seniority and re-hire. The Grossmont-Cuyamaca Community College District has already negotiated these items for adjunct faculty, but there are many other adjunct faculty across the state who do not have these working conditions.

Trustees Debbie Justeson, Mary Kay Rosinski, and Edwin

Hiel all expressed support for the legislation. Justeson pointed out the majority of courses in the District are taught by adjuncts, and the importance in supporting them. Rosinski said one of the Governing Board's top priorities is to provide the best possible working conditions for part-time faculty. Hiel said part-time faculty need more stability, but the District also needs to address the need for more full-time faculty.

In other docket items, the Governing Board:

- Reviewed and adopted revisions to Board Policies
 BP 2712, Conflict of Interest Code (Form 700 Filers);
 and BP 7330, Communicable Disease.
- Accepted a report on the current budget status, and granting authority to the Chancellor to approve any budget changes; acceptance of revenues, new grants, donations and revisions to the working budget, and grant authority to budget these funds; approval of purchase orders and warrants issued during February 2016; ratification of signatures of agreements.
- Ratified the actions of the Chancellor to accept, budget, and spend, as appropriate, donations to the Grossmont-Cuyamaca Community College District.
- Granted authority to file a Notice of Completion for Bid B15.017 with SWCS, Inc.; Cuyamaca College One Stop HVAC Upgrade; and release retention as allowed in the contract documents.
- Reviewed revisions to administrative procedures AP 2712, Conflict of Interest Code (Form 700 Filers); and AP 7330, Communicable Disease.


