

## GOVERNING BOARD MINUTES OF THE REGULAR MEETING Tuesday, March 18, 2003

The regular meeting of the Governing Board of the Grossmont-Cuyamaca Community College District was held on Tuesday, March 18, 2003, at 6:30 p.m., in the Heritage of the Americas Museum, Cuyamaca College, 900 Rancho San Diego Parkway, El Cajon, California.

## **Call to Order**

The meeting was called to order at 6:30 p.m. by Board President Dr. Timothy Caruthers.

## **Adjourn to Closed Session**

Caruthers adjourned the open session at 6:31 p.m., and the Board met in closed session from 6:32 p.m. until 7:30 p.m., pursuant to Government Code Section 54957.6 to confer with the District Chief Negotiator regarding United Faculty, California School Employees Association (CSEA), Administrators' Association, and Supervisory/Confidential matters.

## Reconvene in Open Session/Announcement of Closed Session Action(s)

Board President Caruthers reconvened the open session at 7:34 p.m. He announced that the Board, in closed session February 18, 2003:

- With a vote of 5-0, adopted management proposals relative to agreements with the United Faculty and the California School Employees Association; and
- With a vote of 5-0, voted to not rehire a probationary instructor for the academic year 2003-2004.

## **Approval of Minutes**

On the motion of Members Kraft/Alexander, with a vote of 4-0 (Member Clark was absent), the Board approved as presented the minutes of the February 18, 2003, regular meeting.

## **Report of the Board President**

Board President Caruthers reported that Trustee Clark was absent due to illness.

## Reports of the Governing Board

Trustee Alexander reported that the SDICCCA Board Alliance continues to work with other California community colleges to achieve equitable funding. The group met in March with area collective bargaining representatives. He, Chancellor Suarez, Vice Chancellor Austin, and Director of Intergovernmental Relations Quittner, also plan to meet with the "ring" colleges in Santa Monica to garner support for our students. Alexander thanked Cuyamaca College and the Exercise Science/Athletic programs for the tour of their facilities.

meeting March 4 to deal with reductions in staff and services. He attributed this to planning and teamwork among the Board and District and College leadership, including the United Faculty. He expressed pride in the District, which, he remarked, has never lost sight of the fact that we are a team working together for a common cause. He added that he has had opportunities to speak to different groups in the last month, and has mentioned what is happening to community colleges, particularly the underfunding. He applauded those working to change that situation. He expressed appreciation for the opportunity to visit the Exercise Science/Athletic programs.

Student Trustee Ferrell concurred with Trustee Cutting's remarks. He commented that the District's planning far surpassed that of another community college district he is associated with. He acknowledged the District's commitment to providing students with services, and expressed pride in being a part of the District. He reported he attended a coalition of Region 10 student leaders last month regarding the budget situation, and the students plan to support one another in campaigns.

## Report of the Chancellor

Chancellor Suarez announced that President Martinez was presented with an Outstanding President Award by the 4CSD (California Community Colleges for Staff Development) for providing outstanding leadership and serving as a role model in staff development.

Suarez called on President Perri, who invited Cuyamaca Academic Senate President Setzer to introduce recipients of the Cuyamaca College Academic Senate Award for Excellence in Teaching: Debra Babylon, Art and Graphic Design; Patricia Santana, Foreign Language; and Heidi Sarmiento-Hardin, Exercise Science. Setzer summarized the selection process and shared student comments.

Suarez invited the Presidents to present items of interest from their respective colleges. In addition to other items, the Presidents commended their respective Academic Senate Presidents for their efforts in promoting the upcoming budget rallies, including gathering postcards, which were delivered to Sacramento March 17 during the community college budget rally.

Vice Chancellor Austin introduced Tim Flood, Grossmont College Director of Campus Facilities/Operations, and commended him for his attitude and knowledge of Grossmont College projects and maintenance, and for never saying "no."

Vice Chancellor McMahan, referencing Trustee Cutting's remarks, acknowledged the hard work done by the College budget committees and the leadership of the College Presidents, which made it unnecessary to schedule a special Board meeting March 4 to deal with potential reductions in staff and services.

Suarez commended McMahan and expressed his personal thanks for the outstanding work she has done.

Director of Intergovernmental Relations Quittner thanked those involved in the post card campaign, noting that 8,000 post cards were delivered to Sacramento for the March 17 community college budget rally. She added that United Faculty Vice President Zoe Close will deliver a letter and more post cards to Sacramento. Quittner also expressed thanks to Cuyamaca College Dean Al Taccone, who met with the media regarding a Cuyamaca student who acquired several social security numbers. She commented that a committee is looking at pending legislation which will restrict use of social security numbers for student identification.

Suarez called the Board's attention to the calendar of events and invited trustees to attend activities as their schedules allow.

Grossmont Academic Senate President Harvey also acknowledged Tim Flood, and thanked Patricia Santana for the positive impact on her daughter, who was a student of Santana's. She thanked President Martinez for his acknowledgement of the efforts on the Grossmont campus in promoting the post card campaign. She called the Board's attention to a packet of information she provided to them, including post cards, a draft letter to the Governor, and a resolution passed by the Senate protesting budget cuts to categorical programs. She thanked Cuyamaca Academic Senate President Setzer and Director of Intergovernmental Relations Quittner for their part in the post card effort. She echoed Trustee Cutting's and Student Trustee Ferrell's remarks regarding working as a team.

Cuyamaca Academic Senate President Setzer acknowledged the spirit of cooperation during this time of crisis, and reported the Cuyamaca Academic Senate passed a resolution strongly supporting and endorsing Resolutions 03-013 in support of equitable State funding for ALL community college students, and Resolution 03-014 opposing proposed State budget cuts that would deny access to thousands of students. He announced plans to present the resolution to the Statewide Academic Senate at an upcoming Plenary Session for consideration. He thanked the Exercise Science/Athletic programs for their presentation and tour earlier in the evening, and commended Coach Rob Woitkowski for closely following his students' academic progress.

Administrators' Association representative Taccone reiterated previous comments, and expressed pride in how well the District and college work together. He reported he attended a budget rally at San Diego City College.

CSEA President Brauer concurred with comments about budget efforts, acknowledging that the District came close to losing people. He thanked everyone who worked hard to avoid that.
