

GOVERNING BOARD MINUTES OF THE REGULAR MEETING Tuesday, November 18, 2003

The regular meeting of the Governing Board of the Grossmont-Cuyamaca Community College District was held on Tuesday, November 18, 2003, at 6:30 p.m., in the Heritage of the Americas Museum, Cuyamaca College, 900 Rancho San Diego Parkway, El Cajon, California.

Call to Order

The meeting was called to order at 6:30 p.m. by Board Vice President Ronald D. Kraft.

Adjourn to Closed Session

Kraft adjourned the open session at 6:31 p.m., and the Board met in closed session from 6:32 p.m. until 7:30 p.m., pursuant to Government Code Section 54956.9 to consult with legal counsel regarding two cases of pending litigation: 1) Kinney vs. GCCCD et al; and 2) Ross vs. GCCCD; Section 54957 to consider a complaint against public employees; and Section 54957.6 to confer with the District Chief Negotiator regarding United Faculty, California School Employees Association (CSEA), Administrators' Association, and Supervisory/Confidential matters.

Reconvene in Open Session

Board Vice President Kraft reconvened the open session at 7:40 p.m. and announced that he would chair the meeting, as Board President Caruthers was unable to attend the meeting.

On the motion of Members Clark/Alexander, with a vote of 3-0-1 (with Trustee Kraft abstaining), the Board approved as presented the minutes of the October 21, 2003, regular meeting.

Student Trustee Collins absent

On the motion of Members Clark/Cutting, with a vote of 3-0-1 (with Trustee Kraft abstaining), the Board declared excused the absence of Trustee Kraft from the October 21, 2003, Governing Board meeting, and authorized compensation pursuant to Education Code Section 72425(c).

Public Hearing

A public hearing was announced on the Docket of Business on Grossmont-Cuyamaca Community College District Resolution 04-012—Conveying an Easement to CoxCom, Inc., dba Cox Communications, presented in Item 307. No public comment was received.

Reports of the Governing Board

Trustee Clark reported she has been out of town for three weeks and, while away, her family's home burned down. She announced she will be out of town for awhile longer to finish up family business, but will be attending Board meetings.

Trustee Cutting expressed appreciation for the pre-Board meeting tour of the Cuyamaca Computer Information Systems (CIS) department. He complimented the District and Colleges for their response to the fire disaster and the quick way in which they responded to students and staff and in their ongoing efforts to determine needs, and the Associated Student organizations on both campuses for stepping up to assist students. He shared a letter from the Rescue Task Force, a volunteer medical relief team, asking the Board to accept an award for District students and staff who suffered losses due to the recent fires. He presented a check in the amount of \$1,500 to Bob Eygenhuysen, Director of Risk Management, for use in disaster relief.

Student Trustee Duncan reported the Associated Students of Grossmont College (ASGC) contributed \$500 to replace students' books that were lost in the fires. She acknowledged ASGC Board members in attendance.

Trustee Kraft expressed appreciation to the Associated Student organizations and reported that he and Trustee Caruthers were evacuated from their homes in Alpine for eight days as a result of the fires. He added that relief efforts are heartwarming.

Report of the Chancellor

Chancellor Suarez reported that the District responded in a professional and commendable way in response to the fires, which resulted in closure of the District for five days. He acknowledged Director of Public Safety Javines and his officers, who were in contact immediately with him, the Presidents, Vice Chancellors, and others. He reported that a Fire Assistance Task Force, comprised of faculty, staff, students, and administrators has been formed and is working diligently to identify and provide assistance to those affected by the fires. He expressed pride in the people we work with.

Suarez presented the Chancellor/Classified Senate Award for November 2003 to Maria Baeza, Word Processing Specialist, Grossmont College. Classified Senate President Rose presented her with gifts on behalf of the Classified Senate.

Suarez announced that the American Association of University Women has honored President Geraldine Perri and Director of Intergovernmental Relations Dana Quittner as Women of Leadership.

Suarez reported that Trustee Cutting received public recognition in the Fall 2003 issue of the Community College League publication, *The News,* for his work with the Rescue Task Force.

Suarez called on President Perri, representing the Cuyamaca College Foundation, Howard Kummerman, Grossmont College Foundation Director, and Stan Schroeder, Director of the GCCCD Auxiliary Organization, to report on College Foundation and Auxiliary Organization activities, as presented in Item 653 (2002-2003 Auxiliary and Foundations Activities Reports). Vice Chancellor McMahan expressed gratitude to staff and family members who responded to the call to help evacuate critical files from the District Offices during the fires. She acknowledged Information Systems staff for performing admirably in helping to get information out throughout the week.

Staff Communication

United Faculty Representative Close thanked the CIS Department for the tour and presentation this evening. She reported she has attended various meetings throughout the State, where commendations were made about the District's planning, resulting in our ability to weather the budget situation better than other districts. She added that the United Faculty continues to work hard in coming to solutions to bargaining issues, and the working relationships that have been established will carry us through. She reported that equalization is being discussed at every meeting, and credited the Chancellor, the Board, and others for spearheading this issue, and expressed optimism that a solution will be forthcoming.

Grossmont Academic Senate President Smith announced that she serves on the Fire Assistance Task Force, and reported that \$6,500 has been distributed through 15 grants to staff and students. She commended the Associated Student organizations for their immediate response and for continuing to reach out to students. She reported that the Grossmont Academic Senate met on Monday, November 3, and responded with ways to reach out to students. Ideas developed at the meeting have been forwarded to other schools affected by the fires.

Cuyamaca Academic Senate President Setzer acknowledged District and College staff for the exemplary response to the fire and commented he feels fortunate to work in an environment like this. He reported the Cuyamaca Academic Senate met November 13 and voted to donate \$500 to the Fire Assistance Task Force.

Setzer reported that he and Grossmont Academic Senate President Smith attended the Statewide Academic Senate Fall Plenary Session October 30-November 1, and keynote speaker Scott Lay, of CCLC, reported on two issues slated for funding: the Prop 98 split and equalization. He credited the Chancellor and Governing Board as the point of origin for the equalization issue. Setzer reported his resolution to hold a breakout session on equalization at the Spring Plenary Session was approved, and he and Smith have been invited by the Faculty Association of California Community Colleges (FACCC) to present an article on equalization for publication in an upcoming issue. He thanked Director of Intergovernmental Relations Quittner for her help with the article. Setzer and United Faculty Representative Zoe Close attended the FACCC conference in San Francisco November 14 and participated in a round table discussion on equalization. The FACCC Board will conduct an open meeting in San Diego January 23, and equalization will be a discussion topic.

Administrators' Association President Taccone added his thanks to those who met in the aftermath of the fires and commended them for their planning in meeting the crisis. He reported the Administrators' Association voted to contribute \$1,000 to the Fire Assistance Task Force and \$1,000 to each of the Associated Student organizations, for a total of \$3,000.

Classified Senate President Rose expressed appreciation to the District for its efforts in dealing with the fire and gave kudos to the Cuyamaca Grounds and Maintenance Departments for their efforts in cleaning the campus. He pledged \$200 from the Classified Senate for the Fire Relief Fund.

CSEA Representative McDade added his thanks to those above, and expressed hope that the Auxiliary and College Foundations will continue to grow. He reported that CSEA, as a statewide organization, has donated money to help victims of the Southern California fires.

Supervisory/Confidential Representative Althaus extended condolences to Trustee Clark on the loss of her family home. She thanked the College Foundations for doing an excellent job. She commended the ASGC for its immediate attention to seeing that students who suffered losses in the fires received books. She added that Vice Chancellor Austin was instrumental in making arrangements for book donations through Barnes & Noble.
