# Approval of Minutes

#### Changes to Docket of Business

Chancellor Suarez announced there were no changes to the Docket of Business.

### Reports of the Governing Board

Trustees Garrett and Weeks, and Student Trustee Causton commented on attending the Grossmont College Foundation Gala and the amount of funds that were raised for students.

Trustee Barr expressed his feelings and concern regarding contract negotiations.

Trustee Weeks stated Supervisor Dianne Jacob was delighted with the Local Assistance Center.

Trustee Garrett stated he met with Trustee Barr and Student Trustees Causton and Bernier-Sudano concerning District employment of student trustees, and met with the student trustees to discuss textbook costs.

Student Trustee Causton reported on fund raising events for fire victims, breast cancer research, and student activities.

Student Trustee Bernier-Sudano attended the Fall Assembly for California Community College students and the Accreditation Team meeting with Board members.

### Report of the Board President

Board President Alexander, with a PowerPoint presentation, provided a summary of the activities that occurred during the week of the wildfires (October 22-28, 2007), and thanked employees for their assistance to the colleges with accreditation, campus closures, and the Local Assistance and Command Centers.

#### Report of the Chancellor

Chancellor Suarez reported that the accreditation site visits took place October 22-26, in spite of the wildfires throughout the County of San Diego. He stated concerns were expressed to the accreditation teams about the timing, but that the teams had been advised by the Accreditating Commission to move forward. He stated a diplomatic concern would be registered on the record at the appropriate time.

Risk Management Director Bob Eygenhuysen provided information on the District Smoking Policy Evaluation Plan, stating that a smoking survey had been sent to students, staff, faculty, and administration, and that survey results would be presented at the next Board meeting. Grossmont College graduate Sean Bentz commented on campus smoking. Trustee Caruthers inquired about a report to the Board. Trustee Alexander requested survey results be separately tallied for staff and students for presentation at the December Board meeting.

District counsel Timothy K. Garfield, Esq., presented information on the California Public Record Act, and provided clarification on the legal requirements for responding to requests for information and duplication charges.

The President's Reports were distributed and President Cooke and Vice President Instruction Cristina Chiriboga, on behalf of President Perri, reported on campus activities and events. The reports included preliminary comments and recommendations from the Presidents' exit interviews with the accreditation teams. Both colleges expect favorable reports in January 2008.

Associate Vice Chancellor Intergovernmental Relations, Economic Development and Public Information Quittner provided a legislative update and economic outlook for the 2008/2009 budget.

The Chancellor announced the Calendar of Events was distributed.
