Workshop—Tentative Budget 2009-2010	Workshop
The Chancellor provided opening remarks on the fiscal reality of the State, the District's requirements to approve a Tentative Budget in June, and preparing for major budget reductions in 2008/09 and 2009/2010.	
Vice Chancellor Rearic presented the 2009-2010 budget and reported on the District Services, and Districtwide budgets. The overview included information on the cut to the District's unrestricted General Fund, budget priorities, steps in developing the Tentative and Adoption budgets, closing out the 2008/09 budget, budget assumptions, unrestricted revenue General Fund income, increasing enrollment in light of declining funding, site allocations, expenditures, and budget reduction scenarios and possible solutions. Grossmont College President Cooke and Cuyamaca College Interim President Chiriboga provided insight on the college budget processes, areas of focus, budget priorities, and challenges. No action was taken.
