Chancellor Miles, Classified Senate President Debi Miller, and Vice President Administrative Services Tim Flood presented the Chancellor/Classified Senate Award, plaque, and gift card to Patty Sparks, Administrative Secretary to the Vice President Administrative Services, Grossmont College.

Associated Student Government Cuyamaca College President Bobby Carino and Associated Students Grossmont College President Marc Valenzuela reported on the students' *March in March* advocacy activities in Sacramento, which drew 13,000 participants.

Grossmont Healthcare District and Board of Directors Members Gloria Chadwick, Deborah McElvray, Michael Emerson, Michael Long, and Barry Jantz presented the District with a \$27,000 check to fund two Osher Scholarships. Grossmont College President Sunita Cooke expressed thanks and appreciation to the Board Members for their contributions supporting healthcare education at Grossmont College, for helping to retain nursing faculty, and for providing scholarships.

Vice Chancellor Sue Rearic and District Police Chief Joel Javines provided an overview of the District Emergency Preparedness Plan, which is available on the District website. It includes an *Evacuation Plan* that identifies buildings with more than one story and evacuation chair systems for buildings without ground level access.
