

GOVERNING BOARD MINUTES OF THE REGULAR MEETING Tuesday, August 16, 2011

Governing Board and Districtwide Strategic Planning & Budget Council Members gathered at 4:00 p.m. in the Grossmont College Health & Sciences Building 34-150, and reviewed 2010-2011 Strategic Plan action plan outcomes and had a discussion regarding Grossmont and Cuyamaca Colleges' strategic gains and challenges during the past year, when state budgets imposed limitations on the educational systems and services, and how changes made within District Services and the two colleges helped address difficult financial times and facilitate student success. This meeting continues the discussion concerning GCCCD's Student Success and Completion Initiative.

Board Members Barr, Hiel, Justeson, Rosinski, and Chancellor Miles commended faculty, administrators, and staff on the Grossmont College "tie-dyed" Fall Convocation and expressed appreciation to see original Grossmont College retirees in attendance.

Cuyamaca College Student Trustee Taylor and Associated Students leaders attended a Leadership Retreat. He thanked the Board for supporting the *California Dream Act*, and asked for support of Assembly Bill 844.

Report of the Board President

Board President Garrett commented on the pre-board meeting with Districtwide Strategic Planning & Budget Council regarding 2010/11 strategic planning action plan outcomes and said it was amazing to hear about all of the past year's accomplishments at the colleges and District.

Report of the Chancellor

Citizens' Bond Oversight Committee (CBOC) Chairman Ron Asbury expressed appreciation to the Board for its decisions and involvement in the construction processes. He highlighted the *Proposition R* program's eight-year history of clean audits and exemplary general contracting and construction management for projects completed on time and under budget. New CBOC member Warren Ates, representing the San Diego Building and Construction Trades Council, was introduced.

Chancellor Miles reported on Fall 2011 enrollment numbers being down from Fall 2010; almost 200 fewer classes being offered this Fall; and the efficiency of the automatic registration system placing students on the wait list. She also expressed appreciation to Administrators' Association President Michael Copenhaver and the planning team for the recent managers and supervisors workshop

Vice Chancellor Rearic introduced Interim Associate Vice Chancellor Human Resources Don Averill and stated she would provide a report to the Board on short-term hourly employees at the September meeting.

Grossmont College President Cooke reported on the EOPS/CARE Summer Institute Program and introduced new Director of Nursing, Deborah Delaney and Debbie Yaddow, as the new Dean of Allied Health and Nursing.

Cuyamaca College President Zacovic provided information on the upcoming library displays featuring Constitution Week and 9/11, the Emergency Operations Center drill, and congratulated Debi Miller as the area representative for the Southeast 1 Region of California Community College Classified Senate.
