# Report of the Chancellor

Classified Senate President Debi Miller and retired Grossmont College staff member Marty Armstrong joined Chancellor Miles in presenting the 4<sup>th</sup> Quarter Chancellor/Classified Senate Award, including a plaque and a Barnes & Noble gift card, to Grossmont College Library Multi-Media Technician Karen McCoy.

Gafcon Project Manager Jim Davies presented the semi-annual Gafcon Program Management Report for the last half of 2010. He reported that water damage to Grossmont College buildings during recent storms is under investigation and that a determination will be made as to responsibility.
