Proposition R and State Facilities Funding. Concerning the budget, she reported that for 2011/2012 the District will have an additional shortfall of \$2.8M from the state that is in addition to the \$6.3M midyear cut. This will use the District's set aside, which will leave little money available to carry-over for next year's budget. Districtwide Strategic Planning and Budget Council is working on the 2012/2013 budget solutions.
