# **Linking Planning to Budget**

Chancellor Miles conducted a joint meeting of the Governing Board and DSP&BC on the integrated strategic planning processes.

A PowerPoint presentation was presented and narrated by Grossmont College President Sunita V. Cooke, Cuyamaca College President Mark J. Zacovic, and Vice Chancellor Business Services Sue Rearic. Information was discussed on the following topics:

## 2012-2013 Tentative Budget Workshop

Vice Chancellor Business Services Sue Rearic, Associate Vice Chancellor Business Services Sahar Abushaban, Grossmont College Vice President Administrative Services Tim Flood, and Vice President Cuyamaca College Administrative Services Arleen Satele presented the 2012/2013 tentative budget.

The tentative budget packet was distributed and the PowerPoint provided an overview of the budget planning priorities linked to the Strategic Areas of Focus, and vision, mission, and value statement.

Associate Vice Chancellor Abushaban reported the 2012/2013 tentative budget is built on the worse-case scenario, that being, if the Governor's Tax Initiative on the November General Election ballot fails. It is based on the Governor's January Budget Proposal, and includes no proposal to fund growth or cost of living assessment, a net state apportionment reduction of \$ 4.3M, in addition to prior year cuts, a \$3.7M one-time 2011/2012 dedication of funds by way of Board actions (\$8.2M in current year), workload FTES reduction of 5.56% (reduction of 934 FTES), which reduces the state-funded FTES cap to 15,867. The total 2012/2013 tentative budget is \$146.5M, down from \$172.9M in 2011/2012, and there remain state budget challenges yet to be resolved.

Vice President Flood provided information on the unrestricted 2012/2013 budget assumptions, General Fund shortfall of \$22.8M, (based on projected income of \$87.4M and projected expenses of \$110.2M); and solutions to address the shortfall.

Vice President Satele provided an overview of the FTES history and projections; and unrestricted General Fund allocations and expenditures.

Vice Chancellor Rearic provided information on the budget risks and next steps.

All information provided is posted on the Employee Intranet.

No action was taken.
