Annual Governing Board Evaluation & Goal-Setting Workshop

Following introductions, Dr. Smith facilitated the workshop as the Board conducted its annual progress review of 2011 goals and strategies and development of 2012 goals.

As part of the evaluation and goal-setting, the Board reviewed and discussed the following:

- BP 1200 District and College Mission Statements, finding the statements to be relevant and appropriate
- Strategic Areas of Focus
- Core Indicators of Success and 2010-2011 baseline values pertaining to the five strategic areas of focus: Student Access, Learning and Student Success, Value and Support of Employees, Economic and Community Development, and Fiscal and Physical Resources
- Draft 2012 schedule of conversations about student success
