

GOVERNING BOARD SPECIAL MEETING MINUTES Tuesday, May 16, 2017

Members of the Governing Boards for the Grossmont-Cuyamaca Community College District (GCCCD) and the Grossmont Union High School District (GUHSD) gathered at 3:30 p.m. in the Cuyamaca College Student Center, Room I-208, 900 Rancho San Diego Parkway, El Cajon, California, for the annual East County Education Alliance (ECEA) meeting, a partnership between GUHSD and GCCCD to prepare students to be college and career ready. This continues our conversations about student success.

Call to Order—Board Presidents Garrett and Shield called the meeting to order at 3:44 PM.

Public Presentations—there were none.

Welcome—Chancellor Cindy Miles and Superintendent Tim Glover welcomed the audience.

East County Education Alliance Update

Presenters Vice Chancellor Workforce & Organizational Development John Valencia, Alliance Coordinator Amber Hughes, Cuyamaca College Vice President of Instruction Pat Setzer, GUHSD Director College & Career Readiness Paul Dautremont, GUHSD Assistant Superintendent Teresa Kemper and Grossmont College Vice President of Academic Affairs Katrina VanderWoude.

The update included a <u>PowerPoint</u> presentation, review of the 2016 <u>Joint Board Priorities</u>, and joint confirmation of the East County Education Alliance <u>Blueprint</u> for Success. Highlights included the following:

- Vision, Mission and Goals
- Alliance structure and team membership
- Creation of coordinated outreach team and brochure
- Resources
 - California College Promise Innovation \$1.5M grant award that will provide program support services to implement districtwide outreach and engagement, transportation, data and evaluation software, marketing, and an endowment
 - Fitz Nonprofit Consulting survey of respondents who believe the \$10M goal is attainable and 95% of them willing to make a personal gift
- Creation of the data sharing MOU between GCCCD and GUHSD
- Expanding efforts regarding dual enrollment under College and Career Access Pathways (CCAP) to include an MOU with GUHSD and charter schools

- Higher Edge Scholarship "Promise" defined
 - Launch of Promise Fridays on May 19 for El Capitan High School students and May 26 for Granite Hills High School students
- Formalized Adult Ed Consortium via the development of our updated East Region Adult Education Governing Board, including Mountain Empire Unified School District; and alignment of CTE pathway programs

Next Steps

- Finalizing CCAP Dual Enrollment MOU
- Implementation of data tracking and evaluation system
- Launching the \$10M Higher Edge Promise fundraising campaign
- Fall 2017 East County Education Alliance Summit on November 3, 2017

Chancellor Miles facilitated a discussion of the 2016 Joint Board Priorities, which were unanimously reconfirmed and accepted by both Boards.
