Board President Garrett called the meeting to order at 5:15 p.m.

Board President Garrett reconvened the open session at 6:51 p.m. and gave a powerful commentary about the events in Charlottesville and decried the hatred of the groups formenting the violence. As he asked those in attendance to recite the Pledge of Allegiance, he reminded them that all Americans should keep in mind the final words of the pledge: "liberty and justice for all."

## **Report of the Chancellor**

Vice Chancellor Human Resources Corcoran reported on the Manager & Supervisor Symposium stating it provided workshops on cultural competency, performance management, and leading teams. He thanked Human Resources Director Alyssa Brown for organizing the event.

Grossmont College President Abu-Ghazaleh reported Assemblyman Randy Voepel, in his role as a member of the Assembly Budget Committee, toured Grossmont College, including the Veterans Resource Center, and heard a presentation on Student Success and Support Programs to learn about higher education and the impact of funding.

Cuyamaca College President Barnes announced three Career Technical Educational programs (Ornamental Horticulture, Water and Wastewater Technology, and Environmental Health and Safety Management) received the *Strong Workforce Star Award*, a statewide recognition for demonstrating how the programs led to employment and higher wages for students.

Chancellor Miles reported State Chancellor Eloy Ortiz Oakley issued a frank and assertive vision for student success with targeted goals to close student equity gaps. She said these goals reflect the direction of work already being done in the District for a number of years, making Grossmont-Cuyamaca Community College District well-positioned to meet these challenges.
