# GOVERNING BOARD MINUTES OF THE REGULAR AND ORGANIZATIONAL MEETING

# TUESDAY, DECEMBER 12, 2017

Governing Board members gathered at 4:00 p.m. in the Grossmont College Health & Science Complex, upstairs lobby, for a presentation and discussion on building the pathway for transformational change and how Grossmont College has begun to build the pathways for student success and equity and are coordinating efforts to guide students to their goals. The college is streamlining its onboarding process for new students, revamping the ways students are taught, to accelerate student enrollment and success in higher-level classes, and offering more career planning for students. The presentation was led by Grossmont College President Nabil Abu-Ghazaleh, Dean of Student Success Lida Rafia, Int. Associate Dean of Student Success & Support Programs Courtney Williams, Academic Senate President Tate Hurvitz, English professor Sydney Brown, and three accelerated English students: Erika Cuevas, Miguel Cuevas, and Mike Kitwanda. This continues our conversations about student success.

## Report of the Chancellor

Chancellor Miles, along with President Julianna Barnes, Dean of Admissions & Records & Financial Aid Aaron Starck and Administrative Assistant Dawn Heuft presented the 2018 Chancellor/Classified Senate Annual Awards to the following Classified Professionals:

Curriculum co-chairs Kathleen Aylward, Grossmont College, and Peter Utgaard, Cuyamaca College, provided information on curriculum changes for the Spring 2018 course catalog, including changes and modifications to existing courses and degrees and courses approved for distance education.

Vice Chancellor Corcoran, Director of Human Resources Kim Widdes, Cuyamaca College Dean of Student Affairs Lauren Vaknin and Interim Dean of Student Affairs Sara Varghese gave a Title IX activities report and PowerPoint. The presentation reviewed reporting procedures, student and staff training and education on Title IX issues focusing on bystander intervention, outreach activities, two new Title IX informational websites and partnerships with resource organizations, including the Center for Community Solutions in El Cajon.

Vice Chancellor Workforce & Organizational Development Valencia reported that 150 people attended the 4<sup>th</sup> Annual East County Education Alliance Summit with balanced representation from the District and the Grossmont Union High School District. The keynote speaker was Martha Kanter, CEO of the college Promise Campaign and former Under Secretary of Education. A student panel was also featured to discuss barriers faced by students.

President Barnes and President Abu-Ghazaleh discussed the self-assessment process currently underway as a requirement of participation in the Guided Pathways program. Once this is complete, dialogues will take place with the College community to develop plans, which are due for submission in March 2018. Program funding follows completion of these required steps.
