

GOVERNING BOARD MINUTES OF THE REGULAR MEETING Tuesday, October 17, 2017

At 4:00 p.m. Governing Board members participated in a Cultural Competency Workshop facilitated by Dr. Estela Bensimon, Center for Urban Education, Rossier School of Education, University of Southern California. The workshop highlighted the commitment and capabilities needed for an institution to equitably serve students of all races, ethnicities, gender/sexual orientation, and backgrounds with respect to access, success, and campus climate. Bensimon recommended that equity-minded indicators be included in strategic planning, annual reports, faculty hiring and curriculum, and the importance of the District setting equity goals (with specific numerical targets). This continues our conversations about student success.

Vice Chancellor Rearic provided information on docket item 306 regarding 2017/18 Supplemental Funds. She reported that due to difficulty in closing the 2016/17 budget with the District's new fiscal system, all supplemental funds, including capital projects, Student Center funds, and employee benefit trust fund are included in the package to complete the 2017/18 Adoption Budget.

Rearic also provided information on docket item 402 regarding the Facilities Bonds Funding Plan Annual Report stating the District plans to sell the next series of bonds in the spring. Sue said they have completed the process of finding a financial bond advisor.

Chancellor Miles expressed her support for the resolution before the Governing Board in support of deferred action for childhood arrivals or "Dreamers." She noted that rescinding DACA is estimated to shrink the national economy \$200 billion over the next ten years and that arguments against this action are valid on a rational, fiscal, and humanitarian basis. (Board President Garrett expressed appreciation for the efforts to assist students in registering, email blasts and communications.) Miles thanked everyone who participated in the Equity Summit, stating she is very proud of the institutional commitment to developing an equity-minded culture.

Miles reported on the Chancellor's Community Advisory Council meeting, presentation of Padre Johnson paintings in the Heritage of the Americas Museum (President Barnes noted the Padre Johnson painting collection hanging in the Heritage of the Americas Museum are worth \$1 million); the inaugural *Bill & Judy Garrett Civic Leadership Award* and thanked them for their gifts, time, and resources. She also highlighted the *In a Word* event and congratulated Executive Assistants Rosie Ibarra and Myra Lomahan on recent promotions.

President Abu-Ghazaleh reported on zero text book costs and the Annual Banned Books event.

The Chancellor's Cabinet member reports were distributed.

Cuyamaca College Academic Senate President Kim Dudzik and Grossmont College Academic Senate President Tate Hurvitz provided comments and updates.
