**Resolution No. 20-016**

**Emergency Resolution Extending the Deadlines for the Approval of the 2020-21**

**Budget and 2019-20 Audit Report Due to the Effects of COVID-19**

**WHEREAS**, On March 4, 2020, Governor Newsom signed Executive Order No. N-25-20, which acknowledged the impact of COVID-19 on Californians and temporarily extended tax filing deadlines by 60 days.

**WHEREAS**, On March 18, 2020, the Franchise Tax Board announced the postponement of tax filing and payment deadlines until July 15, 2020.

**WHEREAS**, Due to the extension in filing and payment of certain taxes to July 15, 2020, the Department of Finance will not have updated revenue estimates until mid-August.

**WHEREAS**, The state budget, when passed, will likely have numerous revisions, districts will lack critical information to deliberate on local budgets, complete the Annual Financial and Budget Report (311Q), and submit audit reports.

**WHEREAS**, Given the uncertainty in state budget approval timelines and state revenues, California Community Colleges will experience added challenges in local budget development should current deadlines remain in place.

**WHEREAS**, The Chancellor has issued Executive Order 2020-06 temporarily suspending California Code of Regulations, Title 5, sections 58300, 58301, 58305(a), 58305(c), 58305(d), and 59106. (5 Cal. Code Regs. 52020.) and establishing new deadlines for local budgets, annual financial and budget reports (CCFS311), and district audit reports.

**NOW, THEREFORE BE IT RESOLVED**, That the Board of Trustees hereby extends the date established in Administrative Procedure 6200 for the adoption of the 2020-21 Tentative Budget from July 1 to July 21, 2020, for holding a public hearing on the 2020-21 Budget and for the adoption of the 2020-21 Final Budget from September 15 to October 13, 2020. Be it further resolved, that the Board of Trustees extends the date established in Administrative Procedure 6400 for the submission of the 2019-20 Audit Report from December 31, 2020 to February 28, 2021.

**BE IT FURTHER RESOLVED**, That the Board of Trustees authorizes the Chancellor to make necessary appropriations for the routine operations of the District during the period between July 1, 2020 and July 21, 2020.


